told me that on October 1, 2023, a black male entered the store and tried to steal a drink. It told me that he told the male to take the drink out of his pocket, which he did told me that before the male exited the store, he reached inside his shorts, pulled out a gun, and pointed it at him.

I was shown video footage of the incident. The footage was taken on October 1, 2023. At approximately 17:04 hours, the footage shows the black male walking on the left side of the Shells Gas Station and entering the store through the door to the left. At approximately 17:06 hours, the footage shows the male pulling a gun from his shorts, pointing it at the cashier, and the suspect exiting the store through the right door.

I requested the video of the unknown suspect/incident be placed on the Tarrant Police Department's Facebook website to identify the suspect.

The suspect is a black male wearing a black shirt, dark-colored shorts, black socks, black slides (shoes), and short dreadlocks.

Good afternoon. I have concerns about Chief Major putting incorrect information in my reports, changing my narratives, changing my charges to incorrect charges, and submitting a narrative in my name that he completed. Chief Major has done all the above and below allegations without speaking with me first. This has been an ongoing situation that needs to stop.

I submitted report 23005731 in Eforce. Chief Major changed my charge from menacing to Robbery, Forcible Purse Snatching. Chief Major also listed in the property tab a drink as stolen, which needs to be corrected. The subject did not steal the drink.

This case is not a Robbery, Forcible Purse Snatching case, nor was a drink stolen. Therefore, the Chief needs to correct the incorrect information he, Chief Major, listed in my report.

On case number 23005712, Chief Major completed a narrative under my name, which I did not give him permission to do. Chief Major may look at what he did as helping me; however, he is not. The narrative Chief Major completed under my name did not give full details of the incident. I did submit a more detailed narrative.

If my reports need to be corrected, my supervisor needs to speak with me so I can make the necessary changes. At this point, Chief Major is trying to sabotage my reports and make it seem like I am incompetent in my duties as an Officer.

I am working overtime to assist with the staff shortage. I do not have time to go back and check my reports after I submit them for fear that Chief Major may have put incorrect information in my report. It's very concerning to me that he would submit a narrative that he completed in my name, instead of his name.

I have never worked for someone in leadership who constantly makes ongoing incorrect changes to my reports. Before the Chief changes my report, I request that he speak to me first. This is getting out of hand and needs to stop.

Communication is the key. Chief Major has yet to talk with me concerning my reports being incorrect. If he spoke to me first, I would not feel as if he was trying to sabotage my reports and make me feel as if I was incompetent in my duties as a Police Officer.

This situation may be a misunderstanding; however, it is not due to a lack of communication.

Please speak with Chief Major concerning my allegations.
