MINUTES OF THE REGULAR MEETING OF THE CITY OF TARRANT, ALABAMA

HELD ON MONDAY, JULY 6, 2020

The City Council of the City of Tarrant, Alabama met in regular session on the 6th day of July, 2020 at 7 pm at Tarrant City Hall council chambers.

Mayor Pro Tempore Laura Horton Tuck called upon City Attorney Ben Goldman to give the prayer and Police Chief Dennis Reno to recite the pledge.

Anderson moved and Fields seconded the motion to approve the resolution. After Fields pointed out that some citizens with concerns & objection over this resolution were in attendance, Horton first said that resident Allen Bailey is the precinct chief, so those citizens interested in working the polls should talk to him. She then deferred to Goldman, who in turn deferred to the city clerk, Dan Weinrib. Weinrib began by reminding the Council and public that as city clerk, he is responsible for overseeing elections. Weinrib then explained that he reached out to the County Probate Judge's office to obtain their list of poll workers for the Tarrant City Hall precinct. He then talked with longtime precinct chief Allen Bailey, who already checked the availability of his list of poll workers, all of whom had already worked prior elections at City Hall. Weinrib then answered questions and/or concerns from a council member and various citizens, including a mayoral candidate. Matthews requested that all discussions cease until after the meeting, in essence calling for the vote. Upon roll call, the vote was as follows:

Under public comments, a Tarrant citizen asked, and Weinrib confirmed, that the only way for somebody new to become a municipal election poll worker is for a current poll worker to vacate. Mr. Newton once again spoke up objecting to Resolution No. 8675, accusing the city leadership of disregarding the people's interest. Two citizens then spoke up about their not knowing about Resolution No. 8675 until early this evening. Gabriel Mendez elaborated further that not all citizens use Facebook and that the city's website does not even list 2020 Council meetings. He offered to help us update our online presence. The City Clerk told him that the City just voted last month to contract with MuniCode to develop a website that would notify citizens of council agendas, be handicapped accessible and perhaps even be bilingual. When Newton reiterated his objection to the City's decision on poll workers, citizen Debbie Hall reminded Newton that the Probate Court puts limits on the number of poll workers based on population size. Newton conceded her point then reiterated that the City Clerk has the power to appoint poll workers and that he disagrees with the City's decision to appoint this slate of veteran poll workers.

Whereupon, Anderson moved and Fields seconded the motion to approve the City of Tarrant's as well as the Electric Department's submitted vouchers and expenses. The motion passed unanimously.

With no further business on the agenda, the Mayor Pro Tempore adjourned the meeting at 7:39 pm.
