She also reiterated several times that she's still going on trips whether the city pays or not, and requested a roll call vote. After more discussion Council Member Bryant offered resolve to amend the travel authorization to pay for mileage and meals to allow Council Member Freeman to participate in a conference to receive an award. The proposed amendment to this travel authorization went to a roll call vote.

Rev. and Mrs. Matthews addressed the council seeking assistance with getting the city to repair the ditch behind their home. They described issues with the ditch and that a failed attempt to remedy the problem was previously made. The mayor informed them that his hands were tied on making the decision to make the requested repairs due to attendance of Council Members. *At this point in the meeting there were only one Council Member and the Mayor present. Council Members Matthews and Anderson were not present. Council Members Bryant and Freeman walked out minutes earlier.

Cyntha Richardson addressed the council on behalf of her niece and kids at Tarrant Elementar regarding the use of the rec center while outside on recess. Mayor Newton explained that the city allowed the BOE access to the center at an agreed fee of \$10 per day. Now that the Rec Center is being used for more functions and events, they proposed a Mutual Use Agreement. This agreement allowed both parties to use each entities facilities at no charge. This agreement was refused by the BOE.


