Second, Jayla and Samuel White. Mr. and Mrs. White requested trailer approval in the City of Tarrant. Building Inspector affirmed that the trailer request was in a high density residential zone. Councilor Freeman mediated by stating that she would look into the request as it was in her district.

Third, Novalee Williams. Ms. Williams requested a financial update and comparison of the exact amount of dollars were in the General fund beginning with the new administration in 2020 to today's amount. Ms. Williams requested the financial update be posted in the City of Tarrant website.

Fourth, Chris Patterson. Mr. Patterson expressed concerns regarding the City of Tarrant Police Department and the candidate running for the City of Tarrant Mayors Office 2025, Tracie Threadford.

After the public comments, Councilor Threadford made a motion to adjourn. Mayor Newton seconded the motion. A verbal vote was taken. Meeting adjourned at 8:14 pm.
