The Council met to discuss Resolution No. 8865 – Authorizing the Mayor to "reserve for purchase" of one (1) 2022 Dodge Ram 5500 Crew Cab Rescue vehicle for use by the City of Tarrant's Fire and Rescue Department. After distributing handouts described as Exhibit A in resolution, Lt. Bennet addressed the council. He explained the loss of Rescue vehicle #77, which was involved in a collision while on responding to a call in November 2021 and subsequently deemed a total loss by AMIC. Bennet further explained that while researching market values on the loss of the cab and chassis and the equipment box for the insurance adjuster, he came upon the vehicle in question. The vehicle is currently being made and the original purchaser has backed out of the sale. NAFECO, the dealer, has agreed to complete the vehicle to our specifications and sell to the city. Bennet also explained that the usual lead time for a rescue vehicle is 18-24 months and that a signed contract is required to hold the vehicle for purchase. This is the cause for calling a special meeting.

After some discussion Council Member Bryant made motion to approve Resolution no. 8865 with a second from Council Member Anderson. There was no further discussion. Mayor Newton then called for a roll call vote.

Section 1. That the Mayor is hereby authorized to execute an agreement between the City of Tarrant and the Regional Planning Commission of Greater Birmingham for the purpose of redistricting assistance and services in accordance with Federal and State law; and

Section 2. That said contract shall be effective for the period of May 1, 2022 through September 30, 2022. Compensation, shall be the exact sum of \$8,000.00 for contracted services, as outlined in said contract; and

Section 3. That a copy of said Contract is attached and labled Exhibit A.

#### **RPC OF GREATER BIRMINGHAM**

#### **OVERVIEW OF MUNICIPAL REDISTRICTING POLICIES AND PROCEDURES:**

In accordance with Federal and State law, each municipality that functions by means of a mayor-council form of government and holds city council elections based on city council districts, should redraw their city council districts after the release of the U.S. Census PL 94 – 171 block data from each decennial Census. The law requires the redistricting of city council districts in order to ensure compliance with the Voting Rights Act and the Civil Rights Act. The Regional Planning Commission of Greater Birmingham offers its services to member local municipal governments to complete this task. Because of population increases, decreases, and population shifting within a municipality over time, the population makeup within city council districts changes. The law requires a fair and even population total between each district with no more than a 5% deviation between them, as well as the creation or preservation of a minority district or districts. An amended voting plan should be adopted at least six months prior to elections. The RPC of Greater Birmingham offers its technical expertise and guidance to aid municipalities in this matter. The RPC process for redistricting follows four phases: 1) Initial Review 2) Redistricting 3) Local Review and Adoption 4) Submittal of Plan to the DOJ. The RPC guidelines for this process are as follows:

#### **Initial Review:**

- Agreement with RPC policies and procedures.
- The municipality must submit the legal descriptions and/or maps of the existing council districts to the RPCGB in order for the RPCGB to determine whether changes would need to be made.
- No change may be necessary after initial review.

#### **Redistricting Process:**

If the RPCGB determines that changes in the existing council districts need to be made, technical manipulation of the block data will be made using geographical information systems in order to determine the most appropriate means of bringing the council districts into compliance. Alternative voting plan scenarios may be considered as well.

#### **Local Review and Adoption:**

- The RPCGB will submit up to five proposal(s) to the mayor, city council, and city attorney for review and agreement.
- The municipality is encouraged to have discussions with local organizations that may have any special interest pertaining to voting rights and minority representation.
- The city or town attorney will be required to handle all legal recommendations to the mayor and council.
- The municipality must hold a public hearing to address citizen concerns and input.
- Formal adoption of the proposed council districts by the mayor and council members.

#### **Submittal of Proposal:**

- The RPC will provide any and all maps and/or technical documentation related to the methodology and procedures of the redistricting process.
- The municipality's legal representative must review and approve the plan as well as provide the legal descriptions of the proposed city council districts.
- The municipality's legal representative must transmit a copy of the amended plan and adopting ordinance to the U.S. Department of Justice Voting Rights Division.
- The municipality's clerk must file the adopted plan with the judge of probate within five days of adoption.

#### THE CITY OF TARRANT, ALABAMA

#### And

#### REGIONAL PLANNING COMMISSION OF GREATER BIRMINGHAM

THIS CONTRACT is made and entered into by and between the City of Tarrant, Alabama, (hereinafter referred to as "Tarrant") and the Regional Planning Commission of Greater Birmingham (hereinafter referred to as the "Commission").

WHEREAS, the program contemplated by this Contract is of mutual interest and benefit to Tarrant and the Commission and will further the objectives of Tarrant;

NOW, THEREFORE, in consideration of the premises and mutual understanding herein contained, the parties hereto mutually agree to the following:

#### **ARTICLE 1: WORK TO BE PERFORMED**

Under the terms of this contract, the Commission shall perform the statement of work set forth and described in the attached *RPC Overview of Municipal Redistricting Policies and Procedures*. The process shall not be changed except by a duly executed amendment to this Contract. The process description referred to in the *Overview* will indicate work completed prior to expiration of initial contract.

#### **ARTICLE 2: PERIOD OF PERFORMANCE**

The effective period of this contract is <u>May 1, 2022</u>, through <u>September 30, 2022</u>. Depending on the type of plan, public education, or objections by the Justice Department and/or any interest group(s) that may result in approval delays, the jurisdiction agrees that such delays are not the responsibility of the Commission, though the Commission will work to avoid such delays.

#### **ARTICLE 3: COMPENSATION**

This contract is for the agreed amount of \$8,000. Payment shall be due upon receipt of invoice from RPC. Any additional costs that may occur as a result of fieldwork and/or surveys or time spent for additional Council meetings and/or public hearings will be invoiced at a rate of \$120.00 per hour.

#### **ARTICLE 4: DELIVERABLES**

The Commission shall submit 3 copies of the final map and report once adopted by the Council. The report shall consist of the relevant data prescribed by Federal and State law for such amendments, i.e., Census 2020 PL94-151 data, and will include any relevant tables, charts, graphs, and maps. Additional copies and materials will be provided at a

cost subject to mutual agreement of the parties. Any additional copies of information, such as district boundary legal descriptions, are the responsibility of the jurisdiction.

#### **ARTICLE 5: PROPRIETARY INFORMATION**

Should proprietary information be disclosed by one party to the other in writing and clearly marked as proprietary, the receiving party agrees that such information shall be maintained in confidence for a period of three (3) years from the effective date of this Contract, notwithstanding any termination dates expressed elsewhere in this Contract. The parties will exercise the same standard of care to protect the information received as they do to protect their own proprietary information. All proprietary information and all copies thereof shall be returned to the disclosing party upon written request, except that an archival copy may be retained by the receiving party to document its obligations under this Contract.

#### **ARTICLE 6: NOTICES**

All notices or communications to either party by the other shall be delivered personally or sent via U.S. Mail, postage prepaid, addressed to such party at the following respective addresses for each and shall be deemed given on the date so delivered or so deposited in the mail unless otherwise provided for herein.

This Contract constitutes the entire agreement between the parties and supersedes all previous oral and written agreements relating to the work to be performed hereunder, as well as any terms and conditions of purchase orders or conditions that may be issued by Tarrant. No amendments or changes to this Contract shall be effective unless made in writing and signed by the authorized representative of both parties.
