AN ORDINANCE AUTHORIZING THE ESTABLISHMENT AND IMPLEMENTATION OF AN EMPLOYMENT POLICY HANDBOOK FOR THE CITY OF TARRANT, ALABAMA

WHEREAS, the City Council hereby finds it necessary to update and adopt its established Employment Policy Handbook as a comprehensive guide to the policies and procedures that governs employees of the City of Tarrant and the Tarrant Electric Department; and

WHEREAS, the City Council further finds that the Employment Policy Handbook is meant to ensure compliance with the requirements of the State of Alabama, the Federal Government of the United States as well as Rules and Regulations set forth by the Personnel Board of Jefferson County.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Tarrant, Alabama, while in regular session on the 4th day of April, 2022 as follows:

Section 1. The City of Tarrant's Employment Policy Handbook is hereby adopted.

Section 2. This Ordinance shall become effective when published by posting the same as required by law and upon its adoption.

Section 3. The provision of this Ordinance shall be included and incorporated in the Code of Ordinance of the City of Tarrant, Alabama, as an addition or amendment thereto, and shall be codified as Section 14-12, and shall be appropriately renumbered to conform to the uniform numbering system of the code

Section 4. All ordinances, resolutions or portions thereof, which are inconsistent with the foregoing ordinance, are hereby repealed.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TARRANT in the State of Alabama, as follows:

- **Section 1.** That Subsection (b) of Section 2-22 ("Days, time and place of regular meetings") of Article II entitled "Council Meetings" of Chapter 2 entitled "Administration" of the Code of Ordinances of the City of Tarrant, Alabama, is hereby repealed and deleted in its entirety and the following is substituted in its place:
- "(b) The council shall meet for informal work sessions (pre-council meetings) on the first and third Mondays of each month. The meetings shall commence at six o'clock (6:00) p.m. in the city council conference room at city hall or any other place and time designated and agreed to from time to time by the council. Following the pre-council meeting discussion of agenda items, at the discretion of the President Pro Tempore of the council, and with time permitting, the public in attendance may be permitted to ask one question on an agenda item only. The question and answer period shall be limited to two (2) minutes and will be answered by the President Pro Tempore or his/her designee. No follow-up or second question by the same person on the same agenda item or another agenda item will be permitted unless all other persons with questions on an agenda item have had an opportunity to ask their question. At no time shall the question and answer period during a pre-council meeting encroach upon the time of the regular city council meeting."
- Section 3. This Ordinance is to become effective immediately upon its adoption by the City Council or as otherwise becoming law. Any and all resolutions and ordinances which are contrary to or in conflict with the terms and provisions of this ordinance are hereby rescinded and repealed.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TARRANT in the State of Alabama, as follows:

- **Section 1.** That Subsection (a) of Section 2-29 ("Preparation of Agenda") of Article II entitled "Council Meetings" of Chapter 2 entitled "Administration" of the Code of Ordinances of the City of Tarrant, Alabama, is hereby repealed and deleted in its entirety and the following is substituted in its place:
- "(a) Any person, firm, partnership, corporation, association or other entity with business or applications to present to the council at a regular meeting must first make application with the city clerk by noon n the Wednesday preceding the council meeting on the following Monday. The purpose of such applications is to provide the pubic and members of the council with advance notice of the presentation and to afford them the opportunity to study and investigate the matter prior to the meeting.

General comments from the public are invited at the end of each meeting. Comments of the public prior to adjournment is an opportunity for the public to inform the Council of matters the public is concerned about, action desired and conditions or situations existing in the City of which the public feels the Council should be aware and consider addressing. There may be allotted a maximum of thirty (30) minutes, at the end of each Council meeting, for any citizen or other party in interest to present comments to the Council on any matter appearing on the agenda, subject to the discretion of the Council. No party may speak more than once on any matter unless upon motion of a Council person and approved by a majority of the Council members present. Public comments shall be limited to two (2) minutes per individual speaking. Public participation may be terminated at the discretion of a Council person and approved by a majority of the Council members present.

In the event an agenda matter has been or will be the subject of a public hearing, no further comments will be taken concerning the matter during this time allotment.

If a party is seeking information, they shall be advised by the Mayor, City Clerk or a member of the City Council how it may be obtained.

- Section 2. That Subsection (d) of Section 2-29 ("Preparation of Agenda") of Article II entitled "Council Meetings" of Chapter 2 entitled "Administration" of the Code of Ordinances of the City of Tarrant, Alabama, is hereby repealed and deleted in its entirety and the following is substituted in its place:
- "(d) The city clerk shall immediately prepare a list of such matters according to the order of business and furnish each member of the council, the mayor and the city attorney with a copy of such lists, together with copies of matters to be presented to the extent that such copies are available on the Friday preceding the regular meeting, and as far in advance of any special or called meeting as time for preparation will permit. The city clerk shall timely deliver such documents and agenda/council packets to the home of any council member who requests such delivery for each or any one regular and/or special meeting."
- **Section 3.** This Ordinance is to become effective immediately upon its adoption by the City Council or as otherwise becoming law. Any and all resolutions and ordinances which are contrary to or in conflict with the terms and provisions of this ordinance are hereby rescinded and repealed.

ORDINANCE NO. 1147

AN ORDINANCE TO AMEND ORDINANCE 992 TO INCLUDE CHECK SIGNING AUTHORITY FOR THE CITY OF TARRANT, ALABAMA

BE IT ORDAINED by the City Council of the City of Tarrant, Alabama, in session duly assembled with a quorum present and by authority thereof as follows:

<u>SECTION 1.</u> Two (2) persons listed below be and are hereby named and authorized to sign, either by hand or by use of mechanical device or facsimile signatures, checks, vouchers or other documents as may be specified hereinafter drawn or relating to the accounts of the City of Tarrant in the various banks with which the City of Tarrant conducts business:

Two council members and two employees. Designated council members will be determined by the council. Designated employees are the principal accountant and city clerk ONLY. Checks are to be signed by close of business each Thursday. Any checks not included will roll to the next week for signage.

<u>SECTION 2</u>. All checks must be signed by one designated council member and one designated employee. At no point should there be two council members or two employees signing at the same time.

SECTION 3. All bank accounts with which the City of Tarrant does business are hereby authorized and requested to accept, honor, cash, pay or transfer, without limit as to the amount and without further inquiry, checks bearing two (2) of the authorized signatures as provided by the immediately preceding resolution whether tendered in payment of an individual obligation or deposited to the account of the City-of Tarrant; and,

SECTION 4. Facsimile signatures may be used under all conditions for the signing of any and all checks or vouchers only upon the authorization of any two (2) of the signatories listed above who are authorized to sign checks or vouchers and that the actual facsimile signatures should be maintained under the care, custody and control of the Tarrant City Clerk and that as a further precaution, all checks must be entered in the check register and all numbers accounted for; and,

First Reading

SECTION 5. Any of the four (4) of the persons authorized hereinabove to sign checks and vouchers drawn in various banks with which the City of Tarrant conducts business are further authorized to, purchase investment securities, and to execute collateralization agreements and documents ("Securities") necessary to provide for or release collateral as well as to sell, assign, transfer, exchange, endorse, substitute, hold, control, deposit or withdraw any funds or Securities; and,

<u>SECTION 6.</u> The City Clerk be and is hereby authorized to access online all accounts in the various banks with which the City of Tarrant conducts business and is granted the authority to transfer funds online among the accounts in the various banks with which the City of Tarrant conducts business including, but not limited to, the City of Tarrant's General Fund at Regions Bank and the Money Market Account.

SECTION 7. To Remove all existing signatories on all existing bank accounts including The General Fund Account, Regions Bank Accounts and Money Market Accounts. The principal accountant shall have five (5) business days after the adoption of this ordinance to have signatories updated on all existing bank accounts. NO NEW ACCOUNTS SHALL BE ESTABLISED FOR ANY PURPISE OF USE FOR THE CITY OF TARRANT, ALABAMA UNLESS FIRST APPROVED BY RESOLUTION, OR ORDINANCE, APPROVED BY THE CITY COUNCIL OF THE CITY OF TARRANT, ALABAMA.

<u>SECTION 8.</u> If any subsection, sentence, clause, phrase, or word of this ordinance, as amended, or any application of it to any person, structure, or circumstance is held to be invalid or unconstitutional by a final decision of a court of competent jurisdiction, then such decision shall not affect the validity of the remaining portions or applications of this ordinance, as amended.

SECTION 9. This ordinance shall become effective immediately upon its adoption, approval and publication or as otherwise provided by law. To the extent that this ordinance is in conflict with other ordinances of the City including, but not limited to Ordinance No. 992, this ordinance shall supersede the others until this ordinance is amended or repealed. This ordinance specifically repeals that part of any heretofore adopted ordinance which empowers any person holding any office or position of employment with the City from having authority to withdraw funds from any financial account maintained at any financial institution in the name of or on behalf of the City or any agency of the City.
