# CITY OF TARRANT COUNCIL MEETING MINUTES MARCH 20, 2023 TARRANT CITY HALL

The City Council of the City of Tarrant, Alabama, met in a regularly scheduled meeting on Monday, March 20, 2023, at 7:00PM at City Hall.

Mayor Wayman A. Newton called the meeting to order at 7:00PM following the council work session that began at 6:00PM to discuss the items on the agenda and other matters.

Chief of Police Wendell Major led those in attendance in the Pledge of Allegiance. Fire Lt. Patrick Bennett gave the invocation.

Mayor Newton asked for a roll call. The following officials were present during the roll call:

Councilor Tracie B. Threaded was absent.

A quorum was determined to be present for the meeting.


The minutes from the March 6 202, regularly scheduled council meeting were presented for review and approval. After review, councilor Anderson moved to approve the minutes as presented. Councilor Bryant seconds of a motion. Mayor Newton called for a roll call vote.

The following items were communicated from the Mayor's office to those in attendance:

[Note that the United Way presentation on referenced on the agenda took place during the council work session.]

The Mayor announced the Easter Egg hunt will be held on Saturday, April 8, 2023, at Hewitt Park from 11:00AM to 2:00PM. He encouraged all churches and neighborhood associations to attend and set up booth or table for the event. The event would start at 11:00AM with booth access and other activities including some give aways. The egg hunt would begin around 1:00PM. The mayor encouraged all citizens to attend.

This ended the communications from the Mayor's office.

The Mayor next asked for any communications from the city councilors present.

No communications were relayed from the city councilors present.

The Mayor then called for committee reports.

No committee reports were made.

The city council next considered old business.

[Note the council received public comments regarding the vicious animal ordinance in the council work session.]

There being no old business to be brought before the council, the council next considered new business.

Mayor Newton introduced and read Resolution 8999, A Resolution To Rescind Resolution 8998 Granting Limited License for Green Valley Services to Enter City Owned Property for the Purpose of Surveying a Potential Road Bed. After being read, Mayor Newton moved to adopt Resolution 8999. Councilor Anderson seconded the motion. Mayor Newton called for a vote.

The year being five (5) and the nays pen zero (0), the motion to adopt Resolution 8999 was agreed to, and the resolution was adopted.

Mayor Newton next introduced and read Resolution 2000, A Resolution Authorizing Additional Expenditures to Interface E-Force CAD Call Information with Existing Fire Department ERS. After being read, Mayor Newton moved for the adoption of Resolution 8994. Councilor Freeman seconded the motion. After some discussion, including hearing from Fire Lt. Bennett, Mayor Newton then called for a vote.

The yeas being five (5) and the nays being zero (0), the motion to adopt Resolution 9000 was agreed to, and the resolution adopted.

Next, the City Council heard from members of the public who had signed in to speak prior to the meeting.

First, Fire Lt. Ron Lyvers of the Tarrant Fire Department addressed the council expressing his support for Lt. Patrick Bennett to be named fire chief. Lt. Lyvers spoke at length regarding Lt. Bennett's career with the Tarrant Fire Department ("TFD") specifically stating Lt. Bennett has consistently gone above and beyond the call of duty in support of TFD, and that morale was very high in the fire department under Lt. Bennett's interim leadership. Lt. Lyvers has been with TFD twenty-five years.

Second, Fire Lt. Jackson of the TFD spoke in favor of the council next hiring Lt. Patrick Bennett to be fire chief. Lt. Jackson reiterated all that Lt. Lyvers said and offered his own perspective as to why Lt. Bennett should be named the next fire chief.

Third, Mr. Brantley, who resides on Day Street, addressed the council about certain homes on Day Street who do not pay for trash service but are placing trash at the curb for pick up. Mr. Brantley gave the council and mayor a map and stating which homes he believes do not currently pay for trash service. The Mayor stated he had previously had staff check the addresses along Day Street, but they were unable to identify the homes who did not pay for service but were placing the cans curbside. Mr. Brantley indicated that there were still residents who did not pay for the service. The Mayor stated he would forward to the appropriate city department for review and, if necessary, enforcement.

Fourth, a resident of the City spoke thanking the mayor for the responsiveness of the public works department following an eviction along Birmingham Avenue. This lady indicated that, as soon as they were notified, public works responded and cleared the items set out by the sheriff in enforcing the eviction in a prompt and professional manner.

Fifth, a gentlemen, who was a resident of Brummitt Heights, spoke regarding the access points to the landfill. The gentlemen indicated that the trucks along the public roads were tearing up those roads causing an issue for the residents.

Sixth, Ms. Boykin, a readent of the Birmingham section of Brumitt Heights, regarding the truck access and landfill issues to Green Valley Landfill. Specifically, Ms. Boykin asked about who gave the trucks authority to open to the public roads through Brumitt Heights. Ms. Boykin also asked about the City paving Treadwell koa.

This concluded comments from the above

Finally, the council considered the voucher and expenses of the city. Mayor Newton moved to approve the vouchers and expenses as presented Councilor Anderson seconded the motion. Mayor Newton called for a vote.

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A MEMORANDUM OF AGREEMENT BETWEEN THE CITY OF TARRANT AND UNITED WAY OF CENTRAL ALABAMA FOR IMPROVEMENTS TO A PUBLIC PARK LOCATED AT 2247 TREADWELL ROAD (A/K/A/FRANKLIN PARK)

BE IT RESOLVED by the City Council of the City of Tarrant, Alabama while in regular session on Monday, April 3, 2023 at 7:00 p.m. as follows:

Section 1. That United Way of Central Alabama has proposed to construct improvements to the public park located at 2247 Treadwell Road, Tarrant, AL 35217 (a/k/a "Franklin Park"), which is owned by the City of Tarrant.

Section 2. That terms and conditions of said improvements are outlined in the Memorandum of Agreement (the "Agreement") attached hereto.

Section 3. That the Mayor is hereby authorized to enter into the Agreement between the City of Tarrant and the United Way of Central Alabama for said improvements to Franklin Park; and

Section 4. That said Agreement shall commence on the date of execution and continue for a period of 20 years, unless terminated earlier by mutual agreement of the parties.

Section 5. That a copy of said Agreement is attached hereto as Exhibit A and made a part hereof as if fully set forth herein.

# EXHIBIT A

#### MEMORANDUM OF AGREEMENT

This Memorandum of Agreement ("Agreement") is made and entered into this \_\_\_\_ day of March, 2023 by and between City of Tarrant, Alabama (Tarrant) and United Way of Central Alabama, Inc., an Alabama nonprofit corporation (UWCA").

### Background:

Tarrant is the owner of the land located at 2247 Treadwell Road, Tarrant, AL 35217 (Franklin Park). UWCA, along with its affiliate, Hands On Birmingham, Inc., d/b/a United Way Hands On ("Hands On") desires to build several public parks as part of UWCA's centennial celebration. Tarrant and UWCA both desire that UWCA and Hands On build a public park on Franklin Park.

Accordingly, Tarrant and UWCA agree as follows:


### Agreement:

- 1. Purpose of Agreement. This Agreement sets forth the terms and conditions under which Tarrant agrees to permy. UWCA to construct a public park (the "Park") on Franklin Park.
  - 2. Site. The location and lesion of the Park is described in Attachment A hereto.
- 3. <u>Tarrant Retains Ownership</u> To rant retains ownership of Franklin Park and shall be the owner of any new facilities or improvements or any other real or personal property added to 2247 Treadwell Road, Tarrant, AL 3.21% ranklin Park as part of the Park. Nothing contained in this Agreement shall be deemed to convey to UVCA any right, title, or interest in the property except as otherwise provided in this Agree next.
- 4. <u>Permission to Construct Park.</u> Tarrant agrees to grant UWCA the right to construct the Park on the property described above. UWCA and its affiliates shall have the right to access and use the property for the construction of the Park.
  - 5. Representations and Warranties. Tarrant certifies and represents that it
    - (a) Owns Franklin Park free and clear of any encumbrance, and has the unrestricted right to make improvements to Franklin Park; and
    - (b) Is not aware of any easement, law, ordinance, or any other reason that would prevent the construction of the Park;
- 6. Obtaining Necessary Permits and Inspections. UWCA shall be responsible for obtaining all necessary permits and inspections for the construction of the Park. UWCA -shall comply with all applicable laws, regulations, and building codes.
- 7. Construction and Costs. UWCA shall be responsible for design and construction of the Park. Before beginning construction, UWCA shall present the plans for the Park to Tarrant for opportunity to comment. UWCA shall construct the Park utilizing volunteer labor and contract with contractors and subcontractors, if necessary. UWCA shall be responsible for all construction costs, including but not limited to, all materials, labor, and equipment necessary to construct the Park.

- 8. <u>Tarrant to Maintain Site and Facilities.</u> Upon completion of the Park, Tarrant shall have a reasonable opportunity to inspect the Park; if the Park is in acceptable condition, Tarrant shall notify UWCA in writing that it accepts the Park as complete. After acceptance of completion by Tarrant, Tarrant shall maintain the site and facilities of the Park in a clean, orderly and safe condition. Tarrant shall be responsible for any necessary repairs to the facilities of the Park.
- 9. Public Access. Tarrant shall permit the Park to be open to the public during reasonable hours. Tarrant shall operate the Park for the general benefit of the public and shall not restrict the use of the Park for the general benefit of the public. UWCA and Tarrant shall each approve an initial set of reasonable rules and regulations (e.g., hours, age limits, prohibited substances) for the use of the Park. Should Tarrant restrict public access or use of the Park in any way that is, in the reasonable opinion of UWCA, contrary to the intent of this Agreement or the purpose of UWCA to invest funds to establish a safe park for the public, then Tarrant shall pay UWCA a sum of \$65,000 as a partial reimbursement of UWCA's costs, due upon demand after a reasonable period to cure any such default.
- 10. General Cooperation. Tarrant and UWCA shall cooperate in constructing the Park and effectuating the intent of this A greement. Such cooperation may include, for example, Tarrant allowing contractors and last cite s onto its property, both parties signing any application for permit if required by the City, DWCA ensuring any applicable warranty from a manufacturer or contractor shall be transferred to a otherwise benefit Tarrant and entering into further agreements as necessary for the coastraction of the Park.
- 11. <u>Liability and Indemnification</u>. After condiction of the Park, UWCA shall not be liable for any damage to the facility or injuries to passons using the facility. UWCA shall not be liable for any damages arising from any act or omission of Tarant, its employees, agents, or contractors, and Tarrant shall not make any related come against UWCA in any proceeding or manner. Tarrant shall indemnify, defend and hold harmless UWCA from and against any and all claims, damages, liabilities, costs, and expenses (including reconable attorneys' fees) arising from or related to any injury or claim of injury to any person or property arising from or related to the use of the Park and its facilities. During the term of this Agreement, Tarrant agrees to maintain general liability insurance with limits of at least \$2,000 too for be dily and personal injury, death, and property damage in a combined single limit, naming both JWCA and Hands On as additional insureds under the policy.
- 12. <u>Disputes.</u> In the event that a dispute should arise between the parties related to this Agreement, the parties agree to first proceed in good faith to submit the matter to mediation. Costs related to mediation shall be mutually shared between the parties.
- 13. <u>Term.</u> This Agreement shall commence on the date of execution and shall continue for a period of 20 years, unless terminated earlier by mutual agreement of the parties.



### A RESOLUTION DECLARING A PUBLIC EMERGENCY AND AUTHORIZING IMMEDIATE ABATEMENT AND ENFORCEMENT OF CITY ORDINANCES BY CITY OF TARRANT BUILDING OFFICIAL

SUBJECT PROPERTY ADDRESS: 1611 PINSON STREET, TARRANT, AL 35217

WHEREAS, 1611 Pinson Street, Tarrant, AL 35217 is located within the corporate limits of the City of Tarrant; and

WHEREAS, after on March 28 a roof collapse occurred at said 1611 Pinson Street, Tarrant, AL requiring the response of Tarrant Fire Department, Tarrant Police Department and Tarrant Public Works.

WHEREAS, said structure had been previously posted by Tarrant Building Inspections Office as an "Unsafe Building – Do Not Enter" due to the structural integrity of the building.

WHEREAS, due to the recent collapse, Tarrant Building Inspections Superintendent and the Tarrant Fire Marshall finds that the structure located at 1611 Pinson Street, Tarrant, AL 35217 constitutes a public emergency and current conditions render the structure beyond stabilization or repair.

WHEREAS, it is the recommendation of the Tarrant Building Inspections Superintendent and the Tarrant Fire Marshall that the City Council of the City of Tarrant declare that 1611 Pinson Street, Tarrant, AL 35217 constitutes a public emergency and that immediate abatement and demolition of said property is due and necessary

BE IT RESOLVED by the City Council of the City of Tarrant, Alabama while in regular session on Monday, April 3, 2023 at 7:00 p.m. as follows:

Section 1. That the City Council of the City of Tarrant finds that the structure located at 1611 Pinson Street, Tarrant, AL is in imminent danger of collapse and, as such, constitutes a public emergency as said collapse would be detrimental to both the public and surrounding structures.

Section 2. That the City Council of the City of Tarrant hereby further finds that, due to the imminent danger to public health and safety, abatement and demolition of said properties is due and necessary.

Section 3. That further, the City Council of the City of Tarrant hereby authorizes the City of Tarrant Building Superintendent and/or Tarrant Fire Marshall to pursue abatement, demolition and removal of structure located at 1611 Pinson Street, Tarrant, AL 35217, with all fees and costs associated with said abatement being taxed against said property.

# A RESOLUTION DECLARING A PUBLIC EMERGENCY AND AUTHORIZING IMMEDIATE ABATEMENT AND ENFORCEMENT OF CITY ORDINANCES BY CITY OF TARRANT BUILDING OFFICIAL

SUBJECT PROPERTY ADDRESS: 1613 & 1615 PINSON STREET, TARRANT, AL 35217

WHEREAS, 1613 and 1615 Pinson Street, Tarrant, AL 35217 are co-joined structures located within the corporate limits of the City of Tarrant; and

WHEREAS, on March 28 a roof collapse requiring the response of Tarrant Fire Department, Tarrant Police Department and Tarrant Public Works was reported to Tarrant Fire Department by an employee of a business located at 1607 Pinson Street, Tarrant, AL 35217; and

WHEREAS, upon arrival at the scene the Tarrant Fire Marshall and employees of Tarrant Public Works observed recently collapsed roofs on structures located at 1611 and 1613 Pinson Street, Tarrant, AL; and

WHEREAS, said structures, along with the co-adjoined building located at 1615

Pinson Street, had been previously been the subject of concern from Tarrant Fire

Department and the Tarrant Building Inspections Office due to the structural integrity and unsafe conditions of said structures; and

WHEREAS, due to roof collapse, structural integrity and current conditions, Tarrant Building Inspections Superintendent and the Tarrant Fire Marshall finds that the structures located at 1613 and 1615 Pinson Street, Tarrant, AL 35217 constitute a public emergency and current conditions render them beyond stabilization and repair; and

WHEREAS, it is the recommendation of the Tarrant Building Inspections Superintendent and the Tarrant Fire Marshall that the City Council of the City of Tarrant declare that 1613 and 1615 Pinson Street, Tarrant, AL 35217 constitute a public emergency and immediate abatement and demolition of said properties is due and necessary.

BE IT RESOLVED by the City Council of the City of Tarrant, Alabama while in regular session on Monday, April 3, 2023 at 7:00 p.m. as follows:

Section 1. That the City Council of the City of Tarrant finds that the building located at 1613 Pinson Street, Tarrant, AL is in imminent danger of collapse and, as such, constitutes a public emergency as said collapse would be detrimental to both the public and surrounding structures.

Section 2. That, the City Council of the City of Tarrant hereby further finds that the structure located at 1615 Pinson Street, Tarrant, AL is structurally adjoined to 1613 Pinson Street and, as such, also constitutes a public emergency due to its condition and structural integrity.

Section 3. That the City Council of the City of Tarrant hereby finds that, due to the imminent danger to public health and safety, abatement and demolition of said properties is due and necessary.

Section 4. STATEMENT OF FACTS:

Mane Street Bar and adjacent properties (1611, 1613, & 1615 Pinson Street, Tarrant, AL)

On March 27, 2023 at approximately 0950 a phone call was received at the fire station from Novatec on Pinson Street. The employee from Novatec stated they had heard a loud noise and water was now rushing out of the front of the adjacent building. Car 40, Engine 33, Rescue 77 and Car 39 initially responded to the building. TVA showed up shortly after. On arrival we found at 1611 Pinson St. water coming out the front of the building, the front facia and wall of the building was bowed and had several holes in it. E-33 stayed at the front of the structure. Car 40 in Rescue 77 continued to the rear of the structure. It was determined that a partial roof collapse had occurred in the old MANE St. Bar location. A brief rapid search was done of this location to try to verify that no one was inside. It was identified that the roof structure and supports holding up the roof had failed. The interior of this property is dangerous and unsafe for anyone to go inside. The roof structure is pulling away from the brick walls on either side of the business. All firefighters were evacuated from the property/building due to its unsafe manner. It was reported and has been noted that squatters have been frequently staying within these buildings when unsecured. The sidewalk and parking areas in front of this property/building were taped and blocked off due to the potential for a collapse of the front of the structure into the sidewalk/street. Tarrant public works was called in with barricades. Upon investigation of this building at 1611 Pinson St. it was noted that the adjacent building 1613 Pinson St that used to be part of a funeral home had a collapsed roof as well which was approximately 2/3 of the building once elevated pictures were able to be taken. This building is also unsafe and a risk to public safety. The third building 1615 Pinson St's roof is still intact from above but it is unknown as to the structural integrity of the dividing and supporting wall. This building has had squatters in it in the past when unsecured also. It would be unsafe and a potential risk to life safety for anyone to trespass in this third building section also as it could potentially collapse also. It is the intention of the Fire Marshal's office in the interest of Public Safety to report to the city building inspector's office and to City Hall that these two buildings (1611 & 1613 are an immediate hazard to the public. There is a potential collapse hazard. The third building 1615 potentially also is an immediate threat as well as it could collapse if 1611 and 1613 shift or worsen. And no one should be allowed to enter any of these buildings due to the life safety risk. It is recommended that these buildings be demolished in the interest of public safety. No utilities are currently connected to these buildings as far as could be determined.

#### **SUMMERY OF EVENTS**

Report by: David Casian, Inspection Superintendent / Director of Public Works

Site Address: 1611, 1613 & 1615 Pinson Street, Tarrant AL.

On October 6, 2022 I received a call regarding 1611 Pinson Street regarding a hazardous / public health situation. After initial observation revealed evidence of transient occupation, Tarrant Police was called. Once TPD cleared the building, an emergency clean-up was conducted due to deplorable living conditions created by transient activity.

History of site investigation: Prior to the site clean-up. Transients had been removed from the property several times by the inspection division due to squatting in a dangerous storage area located at the rear of the Main St Bar. It was explained to property owner, Mr. Randy Lowe that due to the severity of compromise to the structural integrity of the building, specifically the roof, the structure could not be occupied until a site evaluation is conducted by an engineer, a plan is discussed with the inspection division, permits for said work is obtained and inspection approval generating a new certificate of occupancy for the business use. Mr. Lowe replied that "the roof is fine, it is the adjacent business that is damaged". I again reiterated to Mr. Lowe again the site cannot be occupied and the building was posted as an "Unsafe Building — Do Not Enter."

On March 24, 2023 I received a call from Chris Muir regarding a business sign imposing a hazard over a public way; I instructed Mr. Muir to take necessary measures to eliminate any imminent threat to public safety.

On March 28, 2023 I received a call from Patrick Bennett, Tarrant Fire Marshal, regarding a roof collapse at 1611 (Main Street Bar) informing me of the concerns of structural integrity of the site and also the adjacent site (JMW Funeral Home 1613/1615 Pinson Street). Both of these sites have previous and current roof damage exposing the building structural elements to be exposed to weather conditions to the extent to compromise the integrity of these sites and threating public safety and the adjoining businesses. The public way (half way into Pinson Street) was secured to protect public safety due to a failing façade adjacent to the pedestrian path.

As the City of Tarrant's Inspection Superintendent, It is of my opinion due to current circumstances, that both 1611 and 1613/1615 Pinson Street (a/k/a/ The Main Street Bar and JMW Funeral Home) be ordered demolished in the interest of public and safety and all involved; any further delay imposes a threat to citizens of the city and a lability to the City of Tarrant.


