# CITY OF TARRANT COUNCIL MEETING MINUTES DECEMBER 18, 2023 TARRANT CITY HALL

The City Council of the City of Tarrant, Alabama, met in a regularly scheduled meeting on Monday December 18, 2023, at 7:00 PM at City Hall.

Mayor Wayman A. Newton called the regular scheduled meeting to order at 7:01 PM following the council work session that began at 6:00PM to discuss items on the agenda and other matters.

Tarrant City Fire Chief Patrick Bennett lead those in attendance in the invocation. Deputy Mayor Lisa Baker lead those present in the Pledge of Allegiance.

Mayor Newton asked for a roll call. The following officials were present during the roll call:

Ms. Heather Lebeschak introduced herself and provided information on the newly founded office of North Jefferson Chamber of Commerce that just opened on Monday December 11, 2023 at 2980 Hawkins Lane.
