#### <u>City of Tarrant</u> <u>Council Meeting Minutes</u> <u>March 18, 2024</u> <u>Tarrant City Hall</u>

The City Council of the City of Tarrant, Alabama, met in a regularly scheduled meeting on Monday March 18, 2024, at 7:00PM at City Hall.

Mayor Wayman A. Newton called the meeting to order at 7:05PM following the council work session that began at 6:00PM to discuss items on the agenda and other matters. The Mayor called for a moment of silence for the recent passing of City of Tarrant Public Works employee Amiri Barham.

Tarrant City Fire Chief Patrick Bennett lead those in attendance in the invocation. City Attorney Michael Brymer lead those present in the Pledge of Allegiance.

Mayor Newton asked for a roll call. The following officials were present during the roll call:

Councilor Catherine "Cathy" Anderson was absent.

A quorum was determined to be present at the meeting.

The minutes from the March 4, 2024 regularly scheduled council meeting were presented for review and approval. Councilor Freeman requested that the minutes record that she is blocked from the City of Tarrant Facebook page. Further, that Ms. Bailey and other citizens are also blocked. Councilor Freeman encouraged anyone who cannot see the City of Tarrant Facebook page to notify the Mayor or the Councilor. After review, Councilor Threadford moved to approve the minutes from March 4, 2024 with the amendment. Councilor Bryant seconded the motion. Mayor Newton called for a vote.

First, the Mayor announced that the 2024 Easter Egg Hunt date has moved from Saturday, March 23, 2024 to March 30, 2024 from 2:00PM to 4:00PM due to staff employees attendance of the City of Tarrant employee funeral.

Next, the Mayor informed those in attendance of an upcoming Gladiator Sports Camp hosted by the City of Tarrant Mayor's Office, Tarrant Recreational Center, City of Tarrant Library and Jefferson County Sheriff's Office, STRAP Organization and 98.7 KISS radio with Scott Evans

and Patrick Coleman as planners. The sports camp is for students between 4<sup>th</sup> and 12<sup>th</sup> grades. Registration begins on March 6, 2024 and it will be held between March 23 and March 31, 2024 at Tarrant Recreation Center from 9am to 4pm. The primary objective of the camp will be to promote critical thinking skills and conflict resolution using basketball, football and soccer. The Mayor listed the organizations and individuals to which the online applications can be forwarded to.

Councilor Threadford presented an award to the City of Tarrant from the Beautification Board for the 2023 City of Tarrant Christmas decorations. The Mayor accepted the award on behalf of the City of Tarrant Public Works Department who was responsible for decorating the City of Tarrant 2023 Christmas.

This ended communications from the Mayors Office.

The Mayor introduced Old Business.

Councilor Freeman reminded the Mayor of Ms. Matthews concern regarding a fence that the City of Tarrant Public Works previously tore down. The Mayor also reassured Councilor Freeman that this would also be resolved.

Next, the City Council reviewed the vouchers and expenses for the City of Tarrant ending March 18, 2024 and Tarrant Electric Department for vouchers and expenses ending March 18, 2024. After review of both vouchers there was question on the City of Tarrant vouchers and expenses ending March 18, 2024. Councilor Threadford moved to approve the vouchers and expenses for the Tarrant Electric Department for weeks ending March 18, 2024. Councilor Threadford noted the motion is specifically for the Electric Department vouchers and expenses. Councilor Bryant seconded the motion. Mayor Newton called for a vote.

First, Chuck Winborn brought up concerns of an employee being terminated and insurance involvement. Mr. Winborn and other members in the meeting chambers continued to review and summarize past arguments.

Second, Will Smith asked when the Chief of Police will get his salary. Mayor Newton responded by informing Will Smith and the Public that the salary will be reinstated when the law suits are settled. There continued to be discussion and debate on the lawsuit.

Third, Ms. Boyken reviewed and summarized past arguments and attempted to resolve the past conflicts. Ms. Boyken also brought up concerns of the Chief of Police's salary. Councilor Threadford affirmed that she will get together with the City Attorney Michael Brymer, Police Chief and his Attorney to draft up a Resolution.

Fourth, Ms. Dill also reviewed and summarized past conflicts and incidents.

Fifth. Mr. Chris Patterson was not present.

Sixth, Chief Wendel Major thanked Council and Community for their support. Chief Major explained why he was maintaining his role as Police Chief and stated he would obediently relieve himself from his role if asked by the Council or the Community.

Mayor Newton began to explain why Chief Major was suspended from his role by describing said abuse of responsibilities and roles of the Police Chief and the City of Tarrant Police database system. Mayor Newton asked Seargeant Williamson to approach the podium and explain the City of Tarrant Police Department and its crime cases of the past few years. The Council and a portion of the public proceeded to leave. Seargeant Williamson approached the podium and proceeded to explain the City of Tarrant Police Department crime cases of the past few years. The City Attorney, the Mayor and a few of the public participants remained in the meeting. A City of Tarrant citizen questioned Seargeant Williamson and the Mayor in regards to the crime data presented. The City of Tarrant citizen also asked for speedbumps to be placed near her place of residence which is located on a hill that blinds traffic control, mainly public transportation including the local school bus. The Mayor assured the resident that there will be follow up on the traffic and road issue.

There being no further comments there was no adjournment. All present left the Meeting Chambers at approximately 8:19PM.

#### **RESOLUTION NO. 9130**

#### A RESOLUTION AWARDING BID AND AUTHORIZING THE NEGOTIATION AND EXECTION OF A CONTRACT FOR THE RIGHT OF WAY CLEARING PROJECT FOR THE CITY OF TARRANT ELECTRIC DEPARTMENT

WHEREAS, the City Council found the Right-of-Way known as 12 KV Feeders 4, 6 & 7 of the Tarrant Electric Department was in need of maintenance work, including general forestry services and clearance for said Right-of-Way with an estimated costs exceeding \$50,000.00 requiring a public works bid be issued pursuant to Title 39 of the <u>Code of Alabama (1975)</u> (the "Project"); and

WHEREAS, the City Council issed an Invitation to Bid on the Project and began accepting proposed bids that were received sealed and opened in public on March 7, 2024, at Tarrant City Hall;

WHEREAS, upon review of the one (1) submitted bid, the City Council has reviewed Certified Bid Tabulations on the Project, and having reviewed same, the City Council finds the lowest responsible bidder to be Corbitt Power & Light, LLC (See "Bid Tabulation – Contractor", attached hereto as Exhibit "A"); and

WHEREAS, having found Corbitt Power & Light, LLC the lowest responsible bidder, the neogitiation of a contract in substantially the same form as the invitation to bid and the lowest responsible bidder's documents that were submitted.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Tarrant, Alabama, while in regular session, a quorum duly assembled as follows:

<u>Section 1.</u> The City Council declares Corbitt Power & Light as the lowest responsible bidder for the Right of Way Clearing Project known as 12 KV Feeders 4, 6 & 7 for the City of Tarrant Electric Department.

<u>Section 2.</u> The City Council hereby awards the bid to Corbitt Power & Light with a total bid of One Hundered and Thirty-three thousand two hundred and fifty and 00/100 Dollars (\$133,250.00) (the "Bid").

Section 3. The City Council hereby authorizes the Superindendent of the City of Tarrant Electrical Department to negotiate, finalize, and execute a contract for the Project with Corbit Power & Light, in conformity with the Bid and the Project Specifications/Invitation to Bid that were submitted.

<u>Section 4.</u> This Resolution shall become effective immediately upon its passage.






