CITY OF TARRANT COUNCIL MEETING MINUTES NOVEMBER 6, 2024 TARRANT CITY HALL

The City Council of the City of Tarrant, Alabama, met in a regularly scheduled meeting on Monday November 6, 2024, at 7:00 PM at City Hall.

Mayor Newton called the meeting to order at 7:00 PM immediately following the council work session that began at 6:00PM to discuss items on the agenda and other matters.

City of Tarrant Fire Chief Patrick Bennett lead those in attendance in the invocation. Tarrant Police Department, Lieutenant Hill lead those present in the Pledge of Allegiance.

Mayor Newton asked for a roll call. The following officials were present during the roll call:

A quorum was determined to be present at the meeting.

The minutes from the October 21, 2024 regularly scheduled council meeting were presented for review and approval. After review, Councilor Anderson provided correction of interpretation that on bottom of page 5, Councilor Matthews stated 3 x that Mayor Newton did not want Ms. Debbie Hall on the Board of Education because she is white. Mayor Newton also wanted on record that Councilor Anderson also said that there was no racism in Tarrant prior to his being Mayor of Tarrant. Councilor Anderson responded that she does not referencing 50's and 60's but references today's Tarrant. Councilor Threadford moved to approve the minutes of the October 21, 2024 meeting with the amendment. Councilor Anderson seconded the motion. Mayor Newton called for a vote.

The yeas being five (5) and the nays being zero (0), the motion to approve the minutes with the added amendment were adopted, and the minutes for October 21, 2024 council meeting were approved with the added amendment.

The Mayor moved on to communications and thanked everyone for participating in the successful City of Tarrant annual 'Trunk or Treat.' Volunteers, Churches, and Council were acknowledged. The Mayor declared that rather than entering Old Business with the introduction and reading of Resolution No. 9191 that the notice served to the Mayor Newton be replaced by the reading of

Resolution No. 9191. The Mayor publicly read the Civil Action lawsuit between Plaintiffs former Police Officer and Current City of Tarrant Magistrate and the current Chief of Police. Councilor Freeman wanted it on record that Mayor Newton bought the current Chief of Police to the Councilors to be hired.

Councilor Freeman presented a public notice from the Jefferson County Department of Health (JCDH). A public meeting will be held virtually on December 3rd 2024 from 6:00pm to 8:00pm to discuss network of air monitoring, access to air monitoring, air quality complaints, and permitting process and opportunities for public involvement. Councilor Freeman provided the phone number for Jason Howanitz at 205.930.1284.

Councilor Threadford provided a reminder of the turkey and food giveaway for this Saturday, November 9, 2024 from 9am to 11am at Tarrant Recreation Center. Two hundred food boxes will be given away on the 2nd Saturday of every month on a first come basis.

There were no committee reports.

The Mayor and Council moved on to Old Business.

Mayor Newton did not introduce and read Resolution No. 9191. A Resolution Removing Chief Wendell Major from the Office of Chief of Police for the City of Tarrant. There was discussion on the quotes that were requested at the last regular scheduled Council meeting. Next, the Council moved to Public Comments.

First, Mr. Chuck Winborn informed the Council of the Mayor and a citizens public confrontation at the annual 'Trunk or Treat' 2024 event. Mr. Winborn also defended the Police Chiefs past and current investigations. And, Mr. Winborn also asked why there is so much difficulty in publicly releasing a video that was cleared by all parties including Department of Human Resources as to be non-threatening.

Second, Kevin Slaughter specifically asked Councilor Bryant the process of City of Tarrant criminal investigations on Public Officials. Councilor Bryant referred the question to the City Attorney who responded that it would depend on the crime, and that the investigation could be referred to the City of Tarrant Police Department or the Jefferson County Sheriff's Office. Mr. Slaughter also asked Councilor Threadford why his residential electricity has been turned off by

the Building Inspector with two different hand written signatures attached to the door. Councilor Threadford responded by indicating that the Building Inspector is under the Mayor's administration, and that she does not authorize the disconnection of electricity in the City of Tarrant private residences. The Mayor responded that he would need to talk with the Fire Marshall and the Building Inspector for clarification. Councilor Threadford recommended a written request for the electricity to be turned back on. Kevin Slaughter also asked for the zoning boundaries regarding the entertainment district for the City of Tarrant. The Mayor confirmed there is no entertainment district in the City of Tarrant.

Third, Jackie Beltaine asked the Council what the process was for the Freedom of Information Act requests. Ms. Beltaine informed the Council that a request was sent in early October and that an email was recently forwarded to the City Clerk regarding the request. Ms. Beltaine further informed the Council that she was told that the City Clerk did not have access to the information and that she was not allowed to talk with the Department Heads. The City Clerk confirmed an August 2024 public video meeting with the Mayor and Deputy Mayor confirming the verbal request that the City Clerk refrain communications from all City of Tarrant staff. Councilor Freeman asked the City Clerk to publicly name the Deputy Mayor. The City Clerk also expressed that Ms. Beltaine uses reporter, newspaper etc...resulting in an interpretation outcome of an unregistered business entity in the City of Tarrant, and that a business license needs to be produced especially if declaring 'no revenue' after public and private information delivery. The City Clerk confronted Ms. Beltaine gained knowledge of City of Tarrant public officials internal emails correspondence.

There being no further comments from the public. Councilor Threadford made a motion to adjourn. Councilor Bryant seconded the motion. A verbal vote was taken. Meeting ended at 8:08

BE IT RESOLVED by the City Council of the City of Tarrant, Alabama while in regular session on Monday, November 4, 2024 at 7:00 p.m. as follows:

Section 1. That the preamble as set forth above is adopted, ratified, and incorporated as if fully set out herein.

Section 2. That it is in the best interest of the City of Tarrant to provide private council for the defense of Lisa Baker, as an employee of the City of Tarrant, in the matter of *Veronica Bandy-Freeman vs. Wayman Newton*, Civil Action No. 2:22-CV-01148-NAD.

Section 3. That the Mayor is hereby authorized to approve payment of all costs associated with the retention of council and ongoing defense of Lisa Baker, as an employee of the City of Tarrant, to include an initial \$10,000 retainer to WeemsLaw, LLC.



A RESOLUTION REQUESTED BY MAYOR WAYMAN NEWTON AUTHORIZING TARRANT ELECTRIC TO ISSUE A ONE-TIME SEVENTY FIVE DOLLAR(\$75) CREDIT TO ALL TARRANT ELECTRIC CUSTOMERS

WHEREAS, Tarrant Electric, a local power company wholly owned and operated by the City of Tarrant, provides essential electric services to residents and businesses within the community; and

WHEREAS, Tarrant Electric has recently reported a cash surplus of \$3,987,515.00; and

WHEREAS, Mayor Wayman Newton continuously advocates for measures that benefit Tarrant residents and businesses; and

WHEREAS, recognizing the financial challenges facing residents, especially those with low or fixed incomes, and with a dedication to providing relief during this holiday season, Mayor Newton proposes a one-time, seventy-five dollar (\$75) credit for each Tarrant Electric customer to alleviate some of these economic burdens; and

WHEREAS, the City Council now considers this proposal, originally put forth by Mayor Newton, as a crucial step toward helping residents and businesses manage rising costs.

BE IT RESOLVED by the City Courcil of the City of Tarrant, Alabama, in regular session on Monday, November 18, 2024, at 7.50 c.m., as follows:

Section 1. The preamble above is hereby adopted ratified, and incorporated as if fully set out herein.

Section 2. The City Council, acknowledging and supporting Mayor Newton's continued commitment to supporting the Tarrant community, approves this one-time seventy-five dollar (\$75) credit to each Tarrant Electric customer to provide immediate economic elief.


Section 3. Tarrant Electric is directed to promptly issue the approved credit to each customer immediately upon the passage of this resolution.

RESOLUTION NOT SUSTAINING MAYOR WAYMAN NEWTON'S TEMPORARY REMOVALS OF SERGEANT CYNTHIA MORROW AND DISPATCHER LASHONDRA JACKSON AND RETURNING THEM BOTH TO ACTIVE SERVICE

WHEREAS, Mayor Waymon Newton under §11-43-81 of the Code of Alabama (1975) temporarily removed Sergeant Cynthia Morrow and Dispatcher LaShondra Jackson.

WHEREAS, The Personnel Board of Jefferson County through its Director of Personnel Dr. Jeffer, Crenshaw has informed the City Council that it recognizes Tarrant City Council appointment of Tarrant Chief of Police as the appointing authority of Tarrant Police personnel via, the Tarrant City Ordinance #1162 restructuring Tarrant Police Department on July 1, 2024, and Tarrant City Council Resolution #2216.

WHEREAS, Sergeant Cynthia Morrow and Dispatcher Lashonda Jackson, by and through their attorney Scott Morro, Esq. amely filed a notice of appeal which remains pending before the Personnel Board of Jefferson County under the adopted Rules and Regulations of the Personnel Board then in place.

WHEREAS, §11-43-81 of the Code of Alabama (1975) confers upon the Council the authority to sustain or refuse to sustain, the permanent removal of a Tarrant employee, Mayor Newton's temporary removal of council-appointed, officers, servants, and employees, Detective Cynthia Morrow and Dispatcher Lashondra Jackson.

WHEREAS, §11-43-55 of the Code of Alabama (1975) confers upon the Council the power to establish a police force and to organize the same under the general supervision of the chief of police, and to provide one or more station houses and to require all things necessary for the maintenance of an

efficient police department. As judged by the Circuit Court of Jefferson County in Newton v Major 01-CV-2023-904087 and 01-CV-2024901091.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

The City Council <u>HAS NOT</u> sustained the personnel decision of Mayor Waymon Newton which purports to terminate **Sergeant Cynthia Morrow and Dispatcher Lashonda Jackson** herein above referenced. The City Council, as appointing authority, does hereby nullify said terminations and reinstall Sergeant Morrow and Dispatcher Lashonda Jackson immediately and restores to them any loss of any benefits of employment that the temporary removal may have caused them to suffer during their porary removal by Mayor Wayman Newton.
