CITY OF TARRANT COUNCIL MEETING MINUTES JANUARY 22, 2025 TARRANT CITY HALL

The City Council of the City of Tarrant, Alabama, met in a regularly scheduled meeting on Monday January 22, 2025, at 7:00 PM at City Hall.

Mayor Newton called the meeting to order at 7:00 PM immediately following the council work session that began at 6:00PM to discuss items on the agenda and other matters.

Ms. Ford lead those in attendance in the invocation. Tarrant Police Lieutenant Hill, lead those present in the Pledge of Allegiance.

Mayor Newton asked for a roll call. The following officials were present during the roll call:

A quorum was determined to be present at the meeting.

The minutes from the December 16, 2024 regularly scheduled council meeting were presented for review and approval. After review, Councilor Bryant moved to approve the minutes of the December 16, 2024. Councilor Freeman seconded the motion. Mayor Newton called for a vote.

The yeas being three (3) and the nays being zero (0), the motion to approve the minutes for December 16, 2024 council meeting were approved.

The Mayor moved on to communications by announcing the City of Tarrrant is accepting the solid waste exemption applications. Criteria is for individuals over the age of 65, with sole source of income to be social security, and the deadline is January 31, 2025. The Mayor provided the City of Tarrant phone number and point of contact for those individuals interested in filling out the said application.

Councilor Freeman stated she had a few questions. Councilor Freeman asked when the Council will be provided with committee information. The Mayor replied that he would provide that for her but could not provide a date. Councilor Freeman then asked how many grants were applied for, approved and how much dollars was received. Mayor Newton stated that he did not know. Councilor Freeman asked if the City received any money back for the demolition of the houses? Mayor stated he did not know. What happened to the money that was found in Chiefs office? Mayor stated he did not know. Councilor Freeman asked the Mayor if he could find out information regarding the questions asked. The Mayor agreed he would provide the requested

information. Councilor Freeman concluded by explaining why she asked about the ARPA funds, and providing revenue ideas.

Mayor Newton added a new law effective January 1, 2025 in regards to mandatory training of a minimum of 5 hours for all elected officials, including Mayors and Councils in municipalities.

There were no committee reports.

The Mayor and Council moved on to Old Business.

Mayor Newton introduced and read Resolution No. 9191. A Resolution Removing Chief Wendell Major from the Office of Chief of Police for the City of Tarrant. The Mayor made a motion to approve Resolution 9191 but did not ask for a second due to the interest of time and personal prediction that the Council would not second the Resolution. The Mayor asked the City Clerk to include Resolution No. 9191 at the next council meeting.

Next, Mayor Wayman Newton introduced and read Resolution No. 9248. A Resolution Affirming the Termination of the Employment of Jason Rickels from the Office of Fire Chief for the City of Tarrant. Mayor Newton made a motion to approve Resolution No. 9248. There was no seconder. Mayor Newton asked the City Clerk to add the Resolution No. 9248 to the next City Council regular scheduled meeting.

The Mayor and Council moved on to New Business

Mayor Newton made a motion to suspend the rules to wave the first reading of Ordinance 1163. An Ordinance Amending Ordinance No. 1160 to Correct the Legal Description that Altered, Rearranged, and Extended the Corporate Limits of the City of Tarrant, Alabama, so as to Embrace and Include Within the Corporate Area of Said City All Territory Now Within Such Corporate Limits and Also Certain Other Territory Contiguous to the City. Mayor Newton made a motion to wave the first reading and to pass Ordinance 1163. Councilor Matthews seconded the motion. Mayor Newton called for a vote. The vote stopped at Councilor Freeman who requested time to think about the Ordinance.

Mayor Newton introduced and read Resolution No. 9249. A Resolution Approving Settlement Agreement Between the City and Aden Market, LLC for Unpaid Taxes. Councilor Bryant made a motion to approve Resolution 9249. Mayor Newton seconded the motion. Mayor Newton called for a vote.

ORDINANCE NO. 1163

AN ORDINANCE AMENDING ORDINANCE NO. 1160 TO CORRECT THE LEGAL DESCRIPTION THAT ALTERED, REARRANGED, AND EXTENDED THE CORPORATE LIMITS OF THE CITY OF TARRANT, ALABAMA, SO AS TO EMBRACE AND INCLUDE WITHIN THE CORPORATE AREA OF SAID CITY ALL TERRITORY NOW WITHIN SUCH CORPORATE LIMITS AND ALSO CERTAIN OTHER TERRITORY CONTIGUOUS TO THE CITY.

WHEREAS, on or about January 8, 2024, property owner, Mr. Harold Finney and Ms. Mary Finney, by and through his agent, submitted a consent petition requesting the City of Tarrant, Alabama, ("City") annex into its corporate limits certain real property located at 2660 Pinson Valley Parkway, Tarrant, Alabama 35217; and

WHEREAS, on or about February 5, 2024, the City Council of the City of Tarrant, Alabama, ("City Council") adopted Ordinance No. 1160 which annexed the property owned by Mr. Harold Finney into the corporate limits of the City which said Ordinance and petition were subsequently recorded in the Office of the Judge of Probate of Jefferson County, Alabama, as Instrument No. 2024099788 on or about October 21, 2024; and

WHEREAS, the property owner's agent discovered an error in the submitted legal description in that the property to be annexed did not include all of the property needed to be annexed for the proposed development; and

WHEREAS, before the City Council of the City of Tarrant, Alabama ("City Council") is an amended application and petition signed by all the owners of all the land within the territory therein described and proposed to be annexed into the City, together with a map of said territory showing its relation to the corporate limits of the City of Tarrant, Alabama ("City") having been filed; and

WHEREAS, having reviewed the petition and application and its contents, the City Council finds it in the best interest of the citizens of the City to amend Ordinance No. 1160 in order to correct the legal description of the property to be annexed by approving the amended petition and application and assent to the annexation of the territory identified in the amended petition and application and include it within the corporate limits of the City.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Tarrant, Alabama, while in regular session on Monday February 3, 2025, at 7:00PM, a quorum duly assembled, as follows:

Section 1. The above-stated preamble is hereby ratified and adopted as if fully set out herein.

Section 2. The City Council, having reviewed the petition and application of all the landowner(s), which is attached as Exhibit "A" to this ordinance and incorporated as if fully set out herein, hereby amends Ordinance No. 1160 to strike the legal description contained in Exhibit "B" and insert the corrected legal description in the Exhibit "B" to this Ordinance.

Section 3. The City Council of the City hereby assent to the annexation of said territory into the City of Tarrant, Alabama, the corporate limits of the City to be extended and rearranged pursuant to the provisions of chapter 42, section 2 of Title 11 of the Code of Alabama (1975) so as to embrace and include said territory in addition to the territory already within its present corporate limits, within the corporate area of said City, which said territory is not within the corporate limits or police jurisdiction of another municipality, and/or the new boundary line does not lie at any point more than half the distance between the old city boundary and the corporate boundary of any municipality. Said territory is further described in the legal description contained on Exhibit "B" to this ordinance which is incorporated herein.

A certified copy of this ordinance containing the legal description of said annexed territory shall be filed with the Judge of Probate of Jefferson County, Alabama, and also cause a copy of this ordinance to be published or posted in accordance with Chapter 42 of Title 11 of the Code of Alabama and provide additional copies of this ordinance to the various state and county departments as may be required or requested.

This ordinance shall become effective immediately upon its passage and Section 5. adoption by the City Council of the City or Tarrant, Alabama, and its publication as required by

For an annexation request, the City requires completion of the Application for Annexation, including the Demographic Questionnaire, the Statement Regarding Provision of City Services, and a copy of the current recorded deeds for the properties proposed to be annexed. A property must be contiguous to the current city limits to be annexed into the City of Tarrant.

Once the completed annexation application is returned to the City, the City's staff will conduct an internal review to determine if the property qualifies for annexation. If it qualifies, an official Petition for Annexation will be created and sent to the application for signature. The Petition for Annexation must be signed by ALL property owners or their legally authorized representative and must also be notarized. Information contained in the Application for Annexation will be forwarded to city departments and service providers for input regarding their ability to provide services to the properties proposed to be annexed. The responses from the departments and service providers will be taken into consideration before action is taken on the request for annexation. The annexation process requires 1 to 2 months for completion. Property owners will receive a letter of notification of annexation once the annexation process is complete.

In the event the property to be annexed is currently inside a fire district, the property owner may be responsible for paying advanced fire dues to the district before the property can be annexed into the city. The applicant / property owner(s) is responsible for verifying whether or not the property to be annexed is inside a fire district, and if so, determining what, if any, fire dues are owed. If fire dues are owed, a letter from the fire district showing the fire dues have been paid. Failure to do so will result in not being able to process the annexation application further since the prepayment of fire dues of properties within fire districts is required under state law for the annexation to be valid.

The Application for Annexation must include a copy of the current recorded deeds for the properties proposed to be annexed.



WHEREAS, since that April, 2024 report, said misconduct has continued and/or escalated, exposing law enforcement officers, the citizens and the City of Tarrant to serious harm; and

where s, his ongoing misconduct includes: (a) continual closing of law enforcement cases pre enting and/or obstructing active investigations (including cases which involve domestic and/or gard violence); (b) retaliation in violation of the Civil Rights Act of 1964; (c) allowing that the personnel unsupervised access to sensitive and confidential areas of the Public Satety Building (including former employees who were terminated for misconduct), (d) hiring personnel outside the rules, policies and procedures as outlined by the Jefferson County Personnel Board and (e) approving contracts, services and/or expenditures without prior authorization.

WHEREAS, based on the findings of misconduct from the April, 2024 independent investigation and the current, ongoing misconduct and exposure to harm to law enforcement officers, citizens and the City of Tarrant, Chief Wendell Major is due to be removed from the Office of the Chief of Police of the City of Tarrant for cause.

NOW, BE IT RESOLVED by the City Council of the City of Tarrant,

Alabama while in regular session on Monday, February 3, 2025 at 7:00 p.m. as follows:

Section 1. That the City Council of the City of Tarrant does hereby immediately remove, for cause, Wendell Major from the Office of the Chief of Police for the City of Tarrant by a majority vote of those elected to the Council.

A RESOLUTION AFFIRMING THE TERMINATION OF THE EMPLOYMENT OF JASON RICKELS FROM THE OFFICE OF FIRE CHIEF FOR THE CITY OF TARRANT

WHEREAS, Chris Patterson, resident and citizen of the City of Tarrant, present the following Resolution Affirming the Termination of the Employment of Jason Rickels From the Office of Fire Chief for the City of Tarrant, and request immediate action from the City Council of the City of Tarrant; and

WHEREAS, Jason Rickels ("Rickels") was appointed to the position of Fire Chief for the City of Tarrant in April, 2015 and remained in that position until his termination by Mayor Wayman Newton in April, 2021; and

WHEREAS (March, 2021, Rickels was arrested in Roswell, Georgia for illegally holding a female African-American Realtor and a male African American Photographer at gun point and violently destroying professional photography equipment, following an unfounded accusation of burglary at 12 \$225,000 Georgia home; and

WHEREAS, according to witnesses, even though the victims had a pre-arranged appointment at the property through the First Multiple Listing Service, they were actively complying with a request to leave the property when Recalls arrived at the property, pulled a handgun and pursued them to their cars before a physical attercation took place; and

WHEREAS, the victims had received the request to leave the property less than 10 minutes prior to Rickels' arriving on scene; and

WHEREAS, prior to and following this incident, Rickels has a history of demeaning behavior and the use of verbally abusive language, particularly toward women and minorities; and

WHEREAS, due to the behavior of Rickels and his subsequent arrest, Mayor Wayman Newton terminated the employment of Jason Rickels in April, 2021 for Commission of a Criminal Offense and Conduct Unbecoming an Officer; and

WHEREAS, approximately two years after his arrest Jason Rickels chose to settle the Georgia incident with a monetary payout rather than face further criminal action; and

WHEREAS, currently the City of Council has before them a second opportunity to affirm the original termination of Jason Rickels' and reaffirm their commitment to protecting the citizens of Tarrant; and

WHEREAS, the citizens of Tarrant should not have to live in fear of a racist and

misogynist Public Official that is tasked with, in this case, saving their lives and the lives of their children; and

WHEREAS, it is requested that the City Council of the City of Tarrant take immediate action reaffirming the original termination of Jason Rickels due to his conduct unbecoming an officer of the City of Tarrant.

NOW, BE IT RESOLVED by the City Council of the City of Tarrant, Alabama while in regular session on Monday, February 3, 2025 at 7:00 p.m. as follows:

- <u>Section 4.</u> As the City Council is the appointing authority for the position of fire chief, the Mayor Pro Tem and one other city councilor are hereby authorized to execute this Resolution.
- <u>Section 5.</u> A copy of this Resolution shall be provided to the City's payroll staff who shall ensure compliance with same forthwith and send written acknowledgment of compliance to the Mayor Pro Tem, Chief Rickels, and the City Attorney.
- <u>Section 6.</u> The City Clerk shall send certified electronic copies of this Resolution to the Personnel Board of Jefferson County as soon as is practical following its adoption.
- Section 7. This Resolution shall become effective immediately upon its adoption and passage.

Jason Rickels' employment with the City of Tarrant was terminated effective April 12, 2021. Rickels timely appealed his termination to the Personnel Board. After being stayed at Rickels request¹, his appeal was heard before a Hearing Officer on July 28, 2022. The Hearing Officer recommended the City's decision to terminate Rickels be upheld. The Board heard additional argument at its August 25, 2022 meeting. Subsequently, the Board upheld the Hearing Officer's recommendation and thus, the City's decision to terminate Rickels.

Rickels timely appealed the Board's decision to the Circuit Court of Jefferson County.

During oral argument before the three judge panel of the circuit court, Rickels, for the first time, asserted that his termination was improper under <u>Alabama Code</u> § 43-11-81 (1975) which provides that the mayor

may remove any officer for good cause, except those elected by the people, and fill the vacancy caused thereby permanently, if the appointment of such officer is made by the mayor, and temporarily, if such officer was elected by the council or appointed with its consent², in either of which last two cases he must report such removal and his reasons therefor to the council at its next regular meeting, when, if

the council shall sustain the act of removal by the mayor by a majority vote of those elected to the council, the vacancy shall be filled as provided in this title.

The Circuit Court found that it did not have "subject matter jurisdiction to render a judgment in Rickels' appeal." (Order May 13, 2024 (CV-2022-902602).

Because the Section 11-43-81 issue was not raised before the Personnel Board, the Personnel Board ordered the matter assigned to a Hearing Officer to address the <u>Ala. Code</u> § 11-43-81 issue and its impact, if any, on the disciplinary action taken against Jason Rickels and what remedy, if any, to which Rickels may be entitled. This hearing was held on September 26, 2024.

The City of Tarrant argued that the Mayor complied with the first part of the statute by placing, in the council's meeting packet for the first meeting after Rickels' termination, a copy of a press release addressing Rickles' termination. Three council members testified at the September 26, 2024 hearing, they testified that they did not receive the press release or did not recall receiving it. The City presented no evidence that the Council voted at that council meeting to sustain the mayor's termination. Three council members testified that no such vote was taken.

The City argued that failure to comply with Section 11-43-81 was a procedural due process argument that Rickels waived by failing to raise with the City or the Personnel Board. This argument was previously raised and rejected by the Circuit Court.

All three Tarrant City Council members who testified at the September 26, 2024 hearing requested this Board send the matter back to the Council for resolution. The Hearing Officer recommended "the matter be returned to the City of Tarrant for compliance with Alabama Code § 11-43-81 and such further action as seems fit." The Board upholds the recommendation of the Hearing Officer. Pending compliance with § 11-43-81, Rickels' employment with the City of Tarrant is reinstated, with the benefits to which he would have been entitled had he not been terminated. Rickels' back pay, if any, is limited to the amount of compensation he would have

received less interim earnings. The City of Tarrant will need to address the employment of its current fire chief, who has completed his probationary period in that position in June 2024.³ Going forward, the City of Tarrant is required to attach a council resolution to any personnel action form related to the employment of the fire chief, or any other position for which the Council has appointment authority.

HEARING OFFICER'S FINDINGS AND RECOMMENDATION

PROCEDURAL BACKGROUND

The Complainant was Chief of the Fire Department of the City of Tarrant, Alabama. He was terminated from this position on or about April 12, 2021. On or about April 21, 2021, the Complainant filed an appeal with the Jefferson County Personnel Board (Board). The Appeal was accepted by the Board and a Hearing Officer was assigned to hear the merits of the case in accordance with Act No. 248, Ala. Acts 1945, as amended also known as the Enabling Act. On or about July 13, 2021, the Complainant filed a Motion to Stay the proceedings, pending outcome of his criminal charges. The Motion was granted and the matter was held in abeyance until May 10, 2022. The Hearing Officer submitted a Report of Findings and Recommendation upholding the decision of the Department Head. On or about August 25, 2022, the Board entered an Order affirming the recommendation of the Hearing Officer. On or about August 31, 2022, the Complainant filed an appeal with the Circuit Court of Jefferson County. On or about February 8, 2024, the 3-judge panel held a hearing, the Complainant raised an issue, for the first time that the City failed to comply

with Ala. Code §11-43-81 which reads: The Mayor shall be the chief executive officer, and shall have general supervision and control of all other officers and the affairs of the city or town, except as otherwise provided in this title. He shall have the power to appoint all officers whose appointment is not otherwise provided for by law. He may remove any officer for good cause, except those elected by the people and fill the vacancy caused thereby, permanently, if the appointment of such officer is made by the mayor, and temporarily, if such officer was elected by the council or appointed with its consent, in either of which last two cases he must report such removal and his reasons therefor to the council at its next regular meeting, when, if the council shall sustain the act of removal by the majority vote of those elected to the council, the vacancy shall be filled as provided in this title. The Court ordered that all parties submit a brief as to the jurisdictional issue. On or about May 13, 2024, the Honorable 3-Judge panel (in a 2-1 decision) ruled that it did not have subject matter jurisdiction to hear the matter because the statute was not complied with and dismissed the matter. The Court gave no instructions to accompany the ruling, nor did it remand the case back to the Personnel Board. The Personnel Board, however, issued an Order on May 23, 2024, stating that a Hearing officer be assigned and address the Ala. Code §11-43-81 issue and its impact, if any, on the disciplinary action taken against Jason Rickels and what remedy, if any, to which The Complainant may be entitled. No other issues or the merits of the case were to be addressed. This was a case of first impression for the Jefferson County Personnel Board.

The Hearing Officer received testimony from Mayor Waymon Newton for the Respondent and Councilmember John Bryant, Councilmember Cathy Anderson, Councilmember Veronica Bandy and the Complainant, Jason Rickels for the Complainant.

Mayor Waymon Newton - testified that he satisfied the notification requirement of the statute by placing a copy of the press release of the Complainant's termination in the council packet for the next council meeting. There was no requirement that the council must act. At a subsequent council meeting, councilman John Bryant attempted to reinstate the Complainant; however, the matter was tabled by another councilmember. A resolution to appoint the current fire chief was approved and passed by the city council by a unanimous vote on June 5, 2023. On cross-examination, the witness was asked if there was really a vacancy in which he replied, yes. He furthered testified that there was no specific formality by which he was required to notify the council. **Respondent rests.**

John Bryant – the witness is member of the City of Tarrant, AL City Council and has been so for 17 years. He testified that it is his understanding that the mayor has the right to fire for good cause. At the next meeting, the person has a right to come to the next meeting and state their side and then the counsel will take action. He doesn't recall being notified of the termination by the mayor. He learned of the termination from a citizen who monitors the City's Facebook page about things that are going on in the City. He brought up the resolution to reinstate the Complainant and back pay; the council tabled the matter and it never came up again. He's seen the press release before; but he doesn't know when. There were no official procedures regarding placing items on the council agenda, just usually receive the council packet about 24 hours before the meeting.

Cathy Anderson – the witness is a member of the City of Tarrant, AL City Council and has been so for approximately 12 years. She learned of the Complainant's termination via FaceBook. She does not recall seeing the press release inside the council packet. The council never took a vote to terminate the Complainant. They will have done so via resolution. The Complainant was not terminated by the council; but by the mayor. She

agrees with the ruling of the Circuit Court. She would like the matter returned to the city for action. Upon cross-examination, she admitted that she introduced the resolution to appoint the current Fire Chief. She saw the Facebook post before the council meeting. Citizens came to the next meeting after the Complainant's termination complaining about the termination and the council went into executive session. However, during the executive session, they did not discuss the Complainant's termination. She does not remember what they discussed.

Veronica Bandy – the witness is a City of Tarrant, AL City Council and has been so for approximately 4 years. She testified that she received the press release from a citizen and doesn't remember seeing it in her council packet. She did not vote to terminate the Complainant. That would have been done by resolution. Any council member may place an item on the council meeting agenda. She did not place the matter on the agenda because she was new to the council at the time and was just trying to learn and just went along with other council members. She voted to appoint the new fire chief.

Jason Rickels – the witness is the Complainant in this matter. He testified that he was improperly terminated and he was not given due process. Upon, cross examination, the witness testified that he never went to the council meeting to discuss his termination. When completing the appeal packet, he marked "all state laws" and Due Process-failure of timely serve. He has not been served with termination papers yet. He did not attend a pre-hearing conference. Upon re-direct, the witness testified that he was never invited to council meeting to discuss his termination. Complainant rests.

The Respondent submitted Exhibits R-1 and R-2. The Complainant submitted no exhibits. The Hearing Officer submitted Exhibit HO-1.

DISCUSSION AND RECOMMENDATION

The Jefferson County Personnel Board was created pursuant to Act No. 248, Ala. Acts 1945 (hereinafter referred to, as amended, as "the Act"), and is also known as the Enabling Act. The Jefferson County Personnel Board is empowered by the legislation under Section 2 of the Act to exercise "control, by rules and regulations and practices..., of all employees and appointees holding positions in the classified service of Jefferson County and its municipalities having populations of over 2,500 people. Under Section 22 of the Act, a dismissed municipal employee "may within ten days after notice [] appeal from the action of the appointing authority by filing with the Board and the appointing authority a written answer to the [disciplinary] charges" against the employee, after which the Board must "order a public hearing of such charges" before itself or a hearing officer, Ex parte Chambers v. City of Birmingham, 137 So. 3d 912. The Complainant's employment with the City of Tarrant was terminated effective April 12, 2021. The Complainant timely appealed his termination to the Personnel Board. The Board assigned the matter to a Hearing Officer as it was required to do, by the Enabling Act. After holding a hearing, the Hearing Officer upheld the termination of the Complainant. The Board confirmed the recommendation of the Hearing Officer (all dates listed above). The Complainant timely appealed his case to the Circuit Court of Jefferson County, Alabama. The 3-judge panel, after reviewing the record and receiving briefs from all parties including and an amicus curiae brief from the City Council of Tarrant City, subsequently dismissed the matter for lack of subject matter jurisdiction because it believed that the Respondent had failed to comply with Ala. Code §11-43-81. The Jefferson County Board, shortly thereafter, entered an order in stating in part: "Because the issue was not raised before the Personnel Board, the record before the Board is silent regarding this issue. Consequently, the Personnel Board orders that the matter be assigned to a Hearing Officer to address the Ala. Code § 11-43-81 issue and its impact, if any, on the disciplinary action taken against Jason Rickels and what remedy, if any, to which Rickels may be entitled. The Hearing Officer shall not hear evidence regarding the underlying conduct that led to the disciplinary action as that information was previously presented and is part of the record before the board."

The Respondent asserts that the Complainant waived the right to assert Ala. Code §11-43-81 because it was not asserted during his initial appeal. The Respondent further asserts that the mayor complied with his portion of the statute by placing a copy of the press release in the council packet as notification and that is all that the statute requires to effectuate the termination. The Hearing Officer disagrees. The statute requires full compliance with the statute, including a notification by the mayor and an affirmation by a majority vote of the city council. The entire statute, as it relates to this termination has to be complied with. Three of the current and then city council members testified that they did not vote to terminate the Complainant. However, it is to be noted that these very same council members voted to appoint the current fire chief, with one of them actually introducing the resolution. The mayor's position was that he did his part and the council members' position is that they didn't do theirs and both parties had a duty under the statute. As stated by the Jefferson County Circuit Court 3-judge panel in its Dismissal Order (noting that one of the judges dissented), all elements of the statute must be complied with, not just a portion. However, this is a catch 22 because the council that was seated 3 years ago may have had a different view of and vote on the matter than the council today.

RECOMMENDATION

Based on the foregoing, it is the recommendation of this Hearing Officer that the matter be returned to the City of Tarrant for compliance with Alabama Code §11-43-81 and such

further action as seems fit. A failure to render this recommendation by this Hearing Officer would be a manifest injustice and a violation of the Complainant's fundamental rights.

This matter is before the Board on Complainant Rickels' November 27, 2024 Motion to Compel Compliance with the Board November 7. 2024 order. That order provides that

Pending compliance with § 11-43-81, Rickels' employment with the City of Tarrant is reinstated, with the benefits to which he would have been entitled had he not been terminated. Rickels' back pay, if any, is limited to the amount of compensation he would have received less interim earnings. The City of Tarrant will need to address the employment of its current fire chief, who has completed his probationary period in that position in June 2024. Going forward, the City of Tarrant is required to attach a council resolution to any personnel action form related to the employment of the fire chief, or any other position for which the Council has appointment authority.

On December 5, 2024, the Personnel Board requested the City of Tarrant provide, no later than December 10, 2024, the status of compliance with the Board's order. The City of Tarrant did not provide the requested status. To date, Rickels has not been reinstated.

The Personnel Board has been advised that the issue of Rickels' reinstatement was on the agenda for the January 6, 2025 Tarrant City Council Meeting. That meeting did not occur due to lack of quorum. The reinstatement of Rickels was discussed at the January 22, 2025 meeting of

the Tarrant City Council. Because the resolution to terminate Rickels was not seconded the mayor asked the resolution be placed on the agenda for the next council meeting. As discussion of the resolution to reinstate Rickels began the mayor left the meeting with an emergency. Consequently, the council no longer had quorum and the meeting was ended. The Board grants the motion to compel.



A RESOLUTION AUTHORIZING THE CITY OF TARRANT BUILDING INSPECTOR TO INSPECT AND DEVELOP A PLAN FOR THE REPAIR OF THE BATHROOMS AT BRUMMITT HEIGHTS PARK.

Whereas, the City of Tarrant, Alabama ("City") is responsible for maintaining Brummitt Heights Park (the "Park"), a public park located within its corporate limits; and

Whereas, the current condition of the bathrooms at the park are such that makes those unusable as the bathrooms are in need of extensive repairs; and

Whereas, in order for the bathrooms to be repaired and to determine if a bid is necessary constructions plans need to be created which requires an engineering firm to inspect the existing bathrooms to determine the most appropriate remedy; and

Whereas, currently, the City of Tarrant ("City") has an employed Building Inspector; and

Whereas, the City Council of the City finds it in the best interest of the health, safety, and welfare of its citizens to authorize the City of Tarrant Building Inspector to inspect the existing bathrooms at Brummitt Heights park and create a repair or construction plan for subsequent review by the City Council.

Now therefore, be it resolved by the City Council of the City of Tarrant, Alabama, while in regular session on Monday, February 3, 2025, at 7:00 p.m. a quorum duly assembled as follows:

RESOLUTION NO. 9258

A RESOLUTION DECLINING TO REARRANGE OR OTHERWISE REDRAW CITY COUNCIL DISTRICTS FOLLOWING THE 2020 DECENNIAL CENSUS.

Whereas, the federal decennial census was last completed in 2020; and

Whereas, the current districts (one through five) from which the city councilors are elected were last redrawn and established in 2016 by Ordinance 1087; and

Whereas, in 2021 the City of Tarrant, Alabama ("City") contracted with the Regional Planning Commission of Greater Birmingham ("RPC") to review the City's current districts and the 2020 decennial census to determine what, if any, changes should be made to the City's district in preparation for the upcoming statewide municipal elections to be held in August 2025; and

Whereas, following a review of the data, the RPC through one of its employees presented the results and recommendations to the City Council of the City of Tarrant, Alabama, ("City Council") in two different work sessions- one in 2021 and the other in 2024; and

Whereas, having reviewed and considered the proposals and finding the RPC and determining that any shift in the population and subsequent demographics is below the threshold requiring any redistricting, the City Council finds it in the best interest of its citizens not to alter or rearrange the boundary lines of its districts as established in 2016 by Ordinance 1087.

Now, therefore, be it resolved by the City Council of the City of Tarrant, Alabama, while in regular session on Monday, February 3, 2025, at 7:00PM, a quorum being present as follows:

Section 1. The above-stated preamble is hereby adopted and incorporated as if fully set out herein.

Section 2. Having received, reviewed, and considered proposals from the RPC following the 2020 decennial census regarding redrawing of the City's current city council districts, the City Council determines and finds that the current boundaries established by Ordinance 1087 adopted in 2016 are satisfactory and shall not be altered at this time.

<u>Section 3.</u> The City Council will review and reconsider the boundary lines following the 2030 decennial census to determine if redistricting may be necessary.

<u>Section 4.</u> The City Clerk shall, upon adoption, provide a certified copy of this resolution to the RPC for its records.

<u>Section 5.</u> This Resolution shall become effective immediately upon its adoption.

AN ORDINANCE REPLEALING ORDINANCE NO. 1155 AND ADOPTING REPLACEMENT ORDINANCE NO. 1155-A ESTABLISHING REQUIREMENTS FOR THE MANAGEMENT AND RETENTION OF SECURITY SURVEILLANCE INFORMATION AND VIDEO.

WHEREAS, the City of Tarrant, Alabama has heretofore adopted Ordinance No. 1155 on the day of, 2023; and
WHEREAS, Ordinance No. 1155 declares that certain video recordings are not public records and the City Council determines that such video recordings should be public records to assure transparency of the City governmental operations; and
WHEREAS, the City Council desires to repeal Ordinance No. 1155 as hereinabove referenced; and
WHEREAS, the City Council desires to replace Ordinance No. 1155 which is herein repealed with replacement Ordinance No. 1155-A.
NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:
1. That Ordinance No. 1155 adopted on the day of 2023 is hereby repealed and replaced by replacement Ordinance No. 1155-A which is attached hereto as Exhibit A; and 2. That the terms of replacement Ordinance 1155-A are retroactive to the date of the adoption of Ordinance No. 1155 on the day of, 2023.

ORDINANCE NO. 1155-A

WHEREAS, the City of Tarrant, Alabama ("City") currently has in place video cameras in and around city hall, the city council chambers, and at other buildings owned by the City; and

WHEREAS, the purpose of these video surveillance systems is to protect city employees and city property as well as for other public purposes, such as video recording for live streaming city council work sessions and meetings; and

WHEREAS, the purpose of this video recording and surveillance system is for the health, safety, welfare and transparency of governmental operations for the citizens of the City; and

WHEREAS, currently, the City's video / information technology vendor operates the video recording and surveillance cameras in and around City Hall and other City owned buildings; and

WHEREAS, any recordings made by the City's video / information technology vendor may be public records, when so designated by the § 41-13-1, et seq., Code of Alabama (1975) unless otherwise excluded due to safety and security concerns as provided by state and federal law; and

WHEREAS, in order to ensure the video and audio recordings are maintained in accordance with the requirements of state law, the City Council of the City of Tarrant, Alabama, ("City Council") finds it in the best interest of of the health, safety, welfare and transparancey of governmental operations on its citizens to adopt and incorporate the Local Records Retention Scheduled as adopted by the Local Government Records Commission should be adopted and formally incorporated as points, and

WHEREAS, further, the Git Council finds it in the best interest of the health, safety, welfare and transparaency of governmental operations for its citizens to provide exclusive access to all video and audio surveillance of city with cameras to the the City Manager, the Chief of Police, and the City's video / information technology, and that said video and audio surveillance recordings are public records of the City as these recordings relate to the transparency of governmental operations of persons and shall be dispused of as provided herein; and

WHEREAS, the recording of any and all public meetings shall be considered public records and maintained in accordance with the Local Records Reter ion Schedule.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TARRANT, ALABAMA, while in regular session with quorum assembles the following:

SECTION 1.

The above-stated preamble is hereby adopted, ratified, and incorporated as if fully set out herein.

SECTION 2.

- A) Except as excluded herein and as provided by state law, the City hereby adopts and incorporates the Local Records Retetion Schedule, as amended from time to time, issued by the Local Government Records Commission for all public records and writings.
- B) This shall include all audio and video recordings of all public meetings and governmental operations held by the city council, a committee, or as otherwise may be subject to the Open Meetings Act (§ 36-25A-1, et seq., Code of Alabama (1975).

SECTION 3.

A) Any and all audio, including any and all internal and external phone calls and internal recordings, and video surveillance filmed and maintained by the internal security surveillance

system used by the City of Tarrant at all city-owned buildings and properties, both internal and external for security purposes and those that are in place to assist with traffic management are hereby declared to be for safety, security purposes, and shall be considered public records.

- B) The Chief of Police (or his or her designee), the City Manager, and the City's video / information technology vendor responsible for the maintenance and upkeep of the system shall be responsible for access and retention of the data that is recorded by these cameras and devices.
- C) Any data (audio [including any and all internal and external phone calls and internal recordings] video, or otherwise) that is recorded by and through the City's internal security surveillance network shall be retained for a period of not less than one (1) calendar year from the date of recording. The Chief of Police (or his or her designee) or the City Manager may direct a longer period of retention, but in no event shall any data be altered, deleted, or erased before the one (1) year time frame has expired.
- D) Governmental operations shall mean the performance of governmental functions by employees of the City or any board or agency of the City. It also includes any action or activity that occurs on City property including buildings, parking lots or open space where City employees may perform their duties or where the public may gain access or any City employee may gain access irespecitive of whether such access is gained or activity occurs during business hours

SECTION 4.

the City Manager, in consultation with the City's video / The Chief of Police ar be responsible for creating, implementing, and enforicing information technology vendor, s nance, state law, and federal law. written policies that conform to this

SECTION 5.

- A) Any employee who violates this ordinartor subsequent written policies created under section 4. shall be subject to appropriate disciplinar measures as determined by the employee's supervisor which may include termination.
- B) Any contractor or vendor who violates this ordinance and the policies issued under section 4. may also be terminated from providing those services to

SECTION 6. SEVERABILITY

The provisions of this Ordinance are hereby declared to be severable if any of these protections, provisions, sentences, clauses, phrases, or parts are held to be unconstitutional or void the remainder shall continue in full force and effect.

SECTION 7. EFFECTIVE DATE.
