The City Council of the City of Tarrant, Alabama, met in a regularly scheduled meeting on Monday October 20, 2025, at 7:00 PM at City Hall.

Next, the City Council moved on to Public Comments.


First, Mr. Winborn. Mr. Winborn declined public comments as his question was geared to Councilor Tracie B. Threadford who was absent for the meeting.


Section 3. The Mayor is hereby authorized to executed this Resolution with attestation of the clerk.
