PROCLAMATION OF THE MAYOR REGARDING THE FIRST AMENDMENT TO THE COVID-19 RESPONSE PLAN FOR THE CITY OF TARRANT, ALABAMA

WHEREAS, on March 15, 2020, on behalf of the City of Tarrant, Alabama ("the City"), the Mayor issued the "Proclamation of the Mayor Regarding the Initial COVID-19 Response Plan for the City of Tarrant, Alabama" ("the Proclamation");

WHEREAS, the findings made in the Proclamation are hereby incorporated by reference as though fully set forth herein;

WHEREAS, this plan may be updated as new information is disseminated;

NOW, THEREFORE, I, Loxcil B. Tuck, Mayor of the City of Tarrant, Alabama ("City"), proclaim and direct the following:

- 1. Except as expressly provided herein, the declarations of the Proclamation shall remain in full force and effect.
- 2. Effective immediately, the following persons shall not enter or remain upon any City of Tarrant-owned facility or property, including Tarrant City Hall, Tarrant Electric Department, Tarrant Public Works, Tarrant Public Safety, Tarrant Public Library, Tarrant Recreation Center, Tarrant Senior Center, and the City's public parks:
 - Persons who have traveled outside of the United States of America within the last fourteen (14) days: China, Iran, United Kingdom and Ireland, South Korea, Austria, Belgium, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal, Slovakia, Slovenia, Spain, Sweden, Switzerland, Monaco, San Marino, Vatican City, or any other country identified by the CDC as subject to a Level 3 Travel Health Notice or as a place of "Widespread"

sustained spread and restrictions on travel to the United States," see https://www.cdc.gov/coronavirus/2019-ncov/travelers/index.html (This list may be updated);

- Persons who reside or have had close contact with someone who has been in one of the countries listed above within the last fourteen (14) days;
- Persons who have been asked to self-quarantine by any doctor, hospital or health agency;
- Persons who have been diagnosed with or have had contact with anyone who has been diagnosed with COVID-19; and
- Persons who have a fever (100.4°F/38°C or higher), cough, have trouble breathing, or are obviously unwell.

Anyone attempting entry in violation of these protocols will be denied entry. Any person who has business to conduct at Tarrant City Hall but is unable to appear because of the restrictions above should contact the appropriate department by telephone at (205) 849-2800. Citizens should also refer to the City of Tarrant's website at http://www.cityoftarrant.com/.

3. Effective March 18, 2020, Tarrant City Hall will have limited public access. No citizen will be allowed in City Hall without a pre-established appointment and subject to the guidelines of this Proclamation. Where possible, business should be conducted by telephone, by email, online, by mail, by drop box in front of City Hall, or by means other than in-person contact. An in-person appointment will only be permitted when one of the foregoing options for contact are not feasible.

The following limitations on visitors will apply to the areas indicated at any given time:

- Tarrant Electric Department customer service 1 visitor
- Tarrant Municipal Court 1 visitor
- Licensing and permitting 1 visitor
- Building official 1 visitor
- City Clerk's office 1 visitor
- Mayor's office 1 visitor

Counter distances have been marked to coincide with CDC recommendations. Please adhere to the restrictive distances.

If waiting outside City Hall, please use the CDC guidelines of distance (which presently recommends six feet of spacing between you and other members of the public).

Please be mindful that our public servants will likely also be affected by the present State of Emergency, and therefore, their availability may be further limited according to their personal situations. We will make every effort to meet citizen needs as they arise.

4. As we work to continue to provide essential services, we ask that citizens utilize the following resources:

- Seek out important information from the City's website (http://www.cityoftarrant.com)
- Call the applicable department via the list of direct department extensions that have been posted on the front door of City Hall and the City's website
- Pay an electric bill online at http://cityoftarrant.com/PayOnline.html, the City has waived all Tarrant Electric Department online account fees during the course of this emergency
- Call (205) 841-1721 to pay an electric bill or to set up an appointment for new services with the Tarrant Electric Department
- Utilize the drop box in front of City Hall for payment to the Tarrant Electric Department
- Pay a Tarrant Municipal Court fine online at https://www.myfinepayment.com/Tix/Default.aspx
- Call (205) 849-2800 ext. 4 to make a payment on a Municipal Court balance or bond
- Pay a Tarrant Municipal Court fine by placing the payment in an envelope marked "ATTN: TARRANT MUNICIPAL COURT" and putting it in the drop box in front of City Hall
- Apply for or renew a business license online or by mail with Avenu Insights &
 Analytics, by utilizing the information available at
